Parish Revolving Fund Financing Agreement.

This FINANCING AGREEMENT has been made and entered on this day of 2022 at between District Local Government/City/Municipality (*Represented by the Chief Administrative Officer/Town Clerk*), and the Beneficiary PDM Enterprise Groups and their household members (*Represented by the Chairperson, Treasurer and Secretary of Parish Development Model Savings and Credit Cooperative Organisation (the PDM SACCO)*).

WHEREAS the Government of Uganda desires to cause the socio-economic transformation of Ugandans and is implementing the Parish Development Model (PDM) to increase household incomes as well as improve the quality of life of Ugandans, with a specific focus on the total transformation of subsistence households (on-farm and off-farm, in rural and urban) to the money economy and market-oriented production.

WHEREAS the Government support will be provided through a Capitalisation Grant to the PDM SACCO, which will be used for the sole purpose of lending to viable income generating activities in the Production, Processing, Marketing and Storage of agricultural products (agricultural value chain development) of the selected Enterprises in accordance with the PDM Production, Processing, Marketing and Storage (Pillar 1) Operational Guidelines and Terms and Conditions of the Parish Revolving Fund articulated in the PDM Financial Inclusion (Pillar 3) Operational Guidelines.
